MINUTES Town of Lexington Executive Session and Special Council Meeting

Town Council held a Special Council meeting on May 17, 2021 at 6:00 p.m. preceded by an Executive Session in the Eli Mack, Sr. Room located at 111 Maiden Lane, Lexington, South Carolina and followed by Council's May Work Session. The meetings were attended by: Mayor Steve MacDougall, Mayor Pro-Tem Hazel Livingston, Councilmembers Kathy Maness (excused following the Executive Session), Todd Carnes, Ron Williams, Steve Baker, and Todd Lyle.

INVOCATION, PLEDGE OF ALLEGIANCE AND CALL TO ORDER:

Mayor MacDougall welcomed everyone to the meeting and announced that the meeting is not being broadcast but minutes would be taken and will be posted to the Town's website after approval. He called on Councilmember Carnes to give the invocation. Mayor MacDougall led in the Pledge of Allegiance. Mayor MacDougall called the meeting to order at 6:08 p.m.

EXECUTIVE SESSION REPORT

Mayor MacDougall reported that the *Executive Session* was called to order at 5:30 p.m. after a motion was made by Councilmember Lyle and seconded by Councilmember Williams to go into *Executive Session*. The motion was unanimously carried. Council adjourned from the *Executive Session* at 6:02 p.m. after a motion was made by Councilmember Baker and seconded by Councilmember Lyle. The motion was unanimously carried. Mayor MacDougall reported that pursuant to SC Code §30-4-70(a) (1) and (2), Council met in *Executive Session* to discuss: three legal items regarding pending litigation, advice regarding agenda items and an existing ordinance; one contractual item regarding a downtown development issue; and no personnel matters. Councilmember Williams to ratify the Mayor's report. The motion was unanimously carried by all those present.

PRESENTATIONS

1. National Safe Boating Week Proclamation – Councilmember Ron Williams: Councilmember Williams read a proclamation proclaiming May 22 – 28, 2021 as Safe Boating Week in the Town of Lexington in order to bring awareness to important life-savings tips for recreational boaters. On average, 600 people die each year in boating related accidents in the United States. Councilmember Williams and Mayor MacDougall presented the proclamation to members of the Lake Murray Coast Guard Auxiliary including Public Affairs Officer Skip Hudson and Recreational Boating Safety District Staff Officer Barbara Burchfield. Ms. Barbara Burchfield thanked the Mayor and Council and presented the Mayor with a Challenge Coin to recognize him for his many years of support to the Auxiliary.

2. **Tourette Syndrome Awareness Day Proclamation – Councilmember Steve Baker**: Councilmember Baker read a proclamation recognizing June 4, 2021 as Tourette Syndrome Awareness Day in the Town of Lexington. Tourette Syndrome is an inherited neurological disorder that is characterized by involuntary physical and vocal tics that occur many times a day and often accompanied by mental health disorders. Councilmember Baker and Mayor MacDougall presented the proclamation to Mr. Joshua Jones. (Copy attached.)

Mr. Joshua Jones thanked the Mayor and Council and encouraged them to let other know about resources that are available through the Greater Carolina Tourette Group or the National Tourette Association of America, both of which can be found on the net.
